ARTICLE A-5 PAYMENT

- 5.1 Payment shall be in accordance with Part 5 of the General Conditions PAYMENT.
- 5.2 Interest
 - .1 Should either party fail to make payments as they become due under the terms of the Contract or in an award by arbitration or court, interest shall be calculated at three percent (3%) per annum above the prime lending rate of the principal banker to the Province and shall become due and payable until payment. Such interest shall be compounded monthly based on the bank rate in effect on the 15th day of each month and

shall be calculated on the number of days since the last compounding of interest or, where no compounding has yet occurred, since the interest commencement date.

.2 Interest shall apply at the rate and in the manner prescribed by paragraph 5.2.1 of this Article on the amount of any claim settled pursuant to Part 8 of the General Conditions - DISPUTE RESOLUTION from the date the amount would have been due and payable under the Contract, had it not been in dispute, until the date it is paid.
